- 1.6 Hold Outreach meetings with facilities, hospital departments to collaborate and promote surveillance activities
- 2.1 Coordinate related departments to address antibiotic use and antibiotic resistance and assist in

the antibiotic stewardship within the hospital and the community

- 2.2 Coordinate and lead the development of the national plan to address antibiotic resistance and stewardship in RMI
- 2.3 Analyze data related to AR, especially all MRO's
- 2.4 Provide education and outreach on AR and stewardship
- 2.5 Assist in the grant progress reports and renewal proposals
- 2.6 Provide HAI support and collaboration
- 3.1 Liaise work within the hospital, physicians, community clinics, infection control practitioners, as well as national professional organization such as the Council of State and Territorial Epidemiologist (CSTE), World Health Organization (WHO), The Pacific Community (SPC) or federal partners such as the Centers for Disease Control and Prevention (CDC) for implementation of the program.
