MAIN DUTIES AND OUTCOMES:

- 1.1 The person in this position manages, plans, and directs the day-to-day facility operations and maintenance of hospitals
- 1.2 To ensure that the establishment runs without problems.
- 1.3 He/she manages buildings and grounds as well.
- 1.4 He/she formulates policies, manages daily operations, and maintains smooth operations at an establishment
- 1.5 Writing of internal SOPs for relevant areas
- 1.6 To focus on using excellent business practice to improve efficiency, by reducing operating costs while increasing productivity.
- 1.7 Advise and manage the hospital administrator with the planning of Majuro Hospital.
- 1.8 A Facilities Engineer must coordinate and work in tandem with the Hospital Administration on issues related to effective office management.

- 2.4 The manager ensures the safety of the building or establishment from fire, flood and other hazards and makes sure that all the equipment and other facilities are working properly.

- 2.2 To also assess current conditions of electrical, plumbing, air conditioning, and other essential utilities and specialized equipment including medical equipment for safety requirement.
- 3.1 Supervision of junior facilities staff
- 3.2 Training of other staff on safety procedures
- 3.3 They initiate an active campaign on the safety of the building and create a schedule of regular evaluations of the facilities.
- 3.4 They are tasked with managing in-house maintenance and engineering staff, recruiting facilities service staff, and training them to ensure competent work output.
- 3.5 Participates in preparing the budget, so that the facilities maintenance team will have adequate funds for its operation and maintenance.
- 3.6 He/she also evaluates the work quality of his staff and subordinates and makes sure that high safety standards are being followed and maintained.
- 3.7 Areas of direct responsibility might include environmental, health and safety issues, electrical engineering, or HVAC (heating, ventilation and air conditioning)
- 3.8 On top of this, the Facilities Engineer should use performance management techniques to monitor and demonstrate the achievement of agreed service levels.

- 3.2 Budgetary responsibilities
- 3.3 They must also coordinate with other Agencies (sample i.e. PMU, etc.) for other needs.
