**JOB PURPOSE:** To Perform comprehensive, affordable, quality patient care and ensure healthy, safe, and friendly environment to an acute and critically ill patient at the Bureau of Kwajalein Atoll Health Services

#### **KEY RESPONSIBILITIES:**

- 1. Responsible for providing quality care to acute and critically ill patients in a highly technical, constantly monitored, and safe environment.
- 2. Responsible for the total holistic care of patient who is facing life- threatening problems with varying needs and treatments.
- 3. Responsible for the total well-being of the patient, physically, psychologically, and spiritually.
- Assess patient's neurological and physical signs and symptoms continually, report
  pertinent changes and take immediate necessary actions base on ICU SOP and
  protocols.
- 5. Collaborate with the attending physician on patient's treatment, care, and management.
- 6. Provide emotional and psychosocial support to patients, family, and significant others.
- 7. Perform other duties within the capacity, qualification and experience expected from person occupying position in this grade.

### MAIN DUTIES AND OUTCOMES:

- **1.1** Provide personalized holistic patient care to acute and critically ill patients in a highly technical, constantly monitored, safe environment.
- **2.1** Plan nursing care, intervention and ensure proper implementation and evaluate results for improvement.
- **3.1** Maintain accurate records of nursing assessment, management, and intervention with proper documentation.
- **4.1** Carries out doctor's orders accurately, with the use of one's sound judgment and ensures proper implementation.
- **5.1** Assists the physician in performing special procedures (ventilation, intubation etc.) and provides emergency nursing care and treatments necessary to prevent complications and preserve life.
- **6.1** Knowledge and skills to operate all technological equipment utilized in the treatment and care of acute and critically ill patients, having in mind proper functioning to ensure patient and staff safety.
- **7.1** Develop and implement individual nursing care plans for each patient and interpret care plans to patient and family.
- **7.2** Ensure participation of family members in the care plan of the patient in preparation for hospital discharge and home care
- **7.3** Assess and monitor a patient's health condition during the shift and ensure pertinence changes are reported to the attending physician for necessary care and treatment.
- **7.4** Ensure correct and accurate patient hand-over report (endorsement) at the end of the shift and document in the patient's chart accurate patient history, treatment, and changes in health status during the shift.
- **7.5** Work closely with the medial staff and multidisciplinary team to accomplish treatment goals of the patient.
- **7.6** Participates in activities that will improve standard of care in the unit.
